

SPO indicators for Farm Size and Average Number of Workers (version 05.08.2019_v2.1)

In the Standard for Small-scale Producer Organizations (SPO), there are two definitions of small-scale producers depending upon the intensity of labour used in the production of different crops (see SPO requirement 1.2.2). In products that are less labour intensive, small-scale producers are defined as those whose farm is operated /managed by members and their families, where farm work is mostly done by members and their families and where members work on their own-account and do not hire workers on a continuous basis. For more labour intensive products, small-scale producers are allowed to hire workers to work alongside the members and their families. Fairtrade International sets a land size for the relevant product categories to define up to which size members are still considered small-scale producers.

Since the definition of small-scale producers varies in different contexts and products, Fairtrade International develops indicators for the farm size, and the average number of workers in some cases. The development of new indicators or review of the existing ones follows the <u>procedure for the</u> <u>development of Small Producer Indicators</u>.

The indicator "Farm size/member" represents the farm size up until when a member is considered a small-scale producer according to Fairtrade Standards.

The indicator "Permanent Workers" (where defined) represents the maximum number of permanent workers hired by an individual member on average per year.
